Step Show Rules & Regulations *(also applies to Exhibition teams)*

1. All teams **must** show up at check-in time.
2. If a team member is reported or observed as having a physical confrontation or provoking a conflict, the team he/she represents will be disqualified.
3. Any vulgar, lewd or obscene language (including lyrics of songs/cds) or gestures is grounds for disqualification.
4. All teams will compete in their appropriate age level.
5. Each team will have a maximum of 6 minutes to perform (including entrance).
6. Each team must provide music (if any) on one CD, labeled with team name.
7. All props and special requirements (if any) must be approved by the Butterfly Project Fund Executive Team no later than March 1st.
8. Registration fees are non-refundable, except in the event of show cancellation.
9. The team that sells or purchases the most tickets by March 1st will receive the Butterfly Project Fund Spirit Award.
10. Each team will be photographed as a team prior to the event, and ALL teams will be photographed at the conclusion of the event.
11. Judge's will use the categories below to judge each team's performance:
